## **Physical Description**

This building that was once a handsome spacious stone villa with a corrugated iron roof and surrounded by broad verandahs, is today a ruin, with no roof and some of the walls standing. The layout was of a similar style to that of the other significant stone building in the Hampton Street precinct.

The walls were made of local stone and rendered with a course conglomerate. Built into one wall was a bottle and wine glass chipped from stone and worked into the stone work. <sup>1</sup> At some stage following the initial construction, internal walls were built of concrete bricks, possibly of local construction.

## **History**

This house was built for Augustus Sanford Roe, the son of Surveyor General Septimus J Roe, in approximately 1887. He was a prominent resident of Roebourne, involved in pearling, shipping and commerce in the north west. He later became resident magistrate and a supreme court judge.

After Mr Roe left Roebourne for Perth, the house was bought by the Sholl brothers and was the homestead building for Weeriana Station before it was transferred to the Stove family in 1913. The Stoves changed the name of the station to Mt Welcome and moved to the present Mt Welcome homestead. Augustus Roe became a Police Magistrate of Perth. He died in 1921 and was buried in Karrakatta.<sup>2</sup>

## Archaeology

There is the potential for archaeologically significant information to be recovered from this site in relation to the use of the structure over time by different prominent members of the local society.

Statement of Significance:	

The ruin is historically significant as a result of its link with the Roe and Sholl families, and thus the well preserved law and order precinct in Roebourne. It is an example of early stone built architectural styles within the town and the west Pilbara. It is a rare example of a domestic residence from the early colonial period.
